## County Inspection Requests Scheduling

As of June 1, 2015, the Pottawattamie County Building Division will be changing our scheduling of inspections. The Building Division will be scheduling all inspection in the morning-AM (8:30 to 12 Noon) or afternoon-PM (12 Noon to 4:00). This change will allow us to be more efficient with driving routes and the Inspectors will be able to fit more inspections into each day.

Inspections must be requested no later than 4:30 PM the business day before in order to be placed on the next working days schedule. For example a person must call in to the Inspection Line (712-328-5847) on Friday before 4:30 PM to be able to secure an inspection for the following Monday AM or PM time slots. Inspection called in the same day (before 8:30 AM) will only receive an afternoon inspection if there is an opening.
